He is a lead author for the 5th assessment report of the IPCC, the co-director of the International Energy Workshop and a lecturer for the PhD in "Science and Management of Climate Change" at the University of Venice. Massimo holds a Laurea cum Laude in Engineering from the University of Bologna, an MSc in Mathematical Economics from the London School of Economics, and a PhD in Political Economics from the Catholic University of Milan.
